In lieu of submission of an erosion and sediment control plan for construction of a **single-family residence**, I agree to comply with any reasonable requirements determined necessary by employees of Mathews County, Virginia, representing the Department of Planning and Zoning. Such requirements shall be based on the conservation standards contained in the Mathews County Erosion and Sediment Control Ordinance, and shall represent the minimum practices necessary to provide adequate control of erosion and sedimentation on or resulting from this project.

Permanent or temporary soil stabilization shall be applied to denuded areas within seven (7) days after final grade is reached on any portion of the site. Temporary soil stabilization shall be applied within seven (7) days to denuded areas that may not be at final grade but will remain dormant for longer than fourteen (14) days. Permanent stabilization shall be applied to areas that are to be left dormant for more than one (1) year.

The inspector has the authority to add or delete erosion and sediment controls as needed in the field, as site conditions warrant.

I further understand that failure to comply with such requirements within three working days following notice by the representatives of Mathews County could result in citation for violation of the Mathews County Erosion and Sediment Control Ordinance.
